**RELEASE OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

WITNESSETH



NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims, and relinquishes unto the Grantor any and all right, title, and interest in and to the Marks granted to Agent by the Grantor by the U.S. Security Agreement, which grant was duly recorded on December 20, 2005, at Trademark Reel 3213, Frame 0790 in the United States Patent and Trademark Office.
