TRADEMARK ASSIGNMENT

WHEREAS, the Mid-Region Council of Governments, a New Mexico regional planning commission established pursuant to the Regional Planning Act, Sections 3-56-1 *et seq.* NMSA 1978, for planning and development district 3, as designated in the Planning District Act, Sections 4-58-1 *et seq.* NMSA 1978,, hereinafter "Assignor," of 809 Copper Avenue, NW, Albuquerque, New Mexico 87102, has adopted on behalf of and as the agent of the State of New Mexico, used on behalf of and as the agent of the State of New Mexico, and is using on behalf of and as the agent of the State of New Mexico the marks NEW MEXICO RAIL RUNNER, NEW MEXICO RAIL RUNNER EXPRESS, and NEW MEXICO RAIL RUNNER and Design; and

WHEREAS, Assignor on behalf of and as agent of the State of New Mexico applied for federal registration of the mark NEW MEXICO RAIL RUNNER in the U.S. Patent and Trademark Office, via Trademark Registration Application Serial No. 76/630,510, filed February 7, 2005; and

WHEREAS, Assignor on behalf of and as the agent of the State of New Mexico applied for federal registration of the mark NEW MEXICO RAIL RUNNER and Design in the U.S. Patent and Trademark Office, via Trademark Registration Application Serial No. 76/631,479, filed February 17, 2005; and

WHEREAS the New Mexico Department of Transportation, a department of the

executive branch of the government of the State of New Mexico, hereinafter "Assignee", is desirous of acquiring said marks and the corresponding applications; and

WHEREAS Assignor has been empowered by Assignee, as the Assignee's agent, to manage a commuter rail system to be known as the NEW MEXICO RAIL RUNNER EXPRESS for the benefit of the people of the State of New Mexico under operating authority granted to Assignee by the Legislature and the Governor of the State of New Mexico, and in that capacity Assignor applied for registration of the marks;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby assign unto Assignee all right, title and interest in and to said mark, together with the goodwill of the business symbolized by said mark and the above identified registration thereof, and all rights to sue and defend for present, past and future infringement.

Assignor warrants that Assignor's rights in said mark, goodwill, and registration have not been previously assigned, mortgaged or otherwise encumbered, and Assignor has full right, power and authority to assign all such rights to Assignee hereunder. The Commissioner of Patents and Trademarks is requested to issue the Certificate of Registration to said Assignee.
