(the "Trade-Marks");

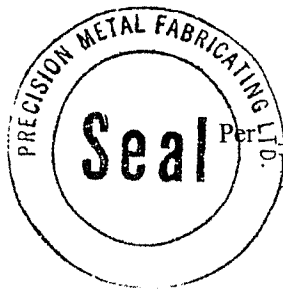
AND WHEREAS Precision wishes to assign all of its rights in and to the Trade-Marks to **HCC**;

It is understood and acknowledged by **HCC** that this assignment is not intended to expand the scope of the Purchase Agreement dated as of October 25th, 2006, by and between Precision and **HCC**;

AND Precision, on behalf of itself, its successors, assigns and legal representatives, hereby covenants and agrees, without further consideration, to do all such lawful acts and things and to execute such further lawful assignments, documents, assurances, applications and other instruments as reasonably may be required by **HCC**, its successors, assigns or legal representatives, to obtain any and all registrations and applications for the Trade-Marks and to vest the same in **HCC**, its successors, assigns or legal representatives.

THIS ASSIGNMENT shall enure to the benefit of and be binding upon **Precision** and **HCC** and their respective successors and assigns.
