## QUITCLAIM ASSIGNMENT OF TRADEMARK AGREEMENT

This Quitclaim Assignment of Trademark Agreement (the "Agreement") is entered into this 2<sup>nd</sup> day of July, 2007 by and between WDLP Broadcasting Company, LLC ("WDLP"), a Delaware limited liability company having an address at 2446 West Whittier Boulevard, Montebello, CA 90640 and Mapalé LLC ("Mapalé"), a limited liability company organized under the laws of Delaware, having a business address at 7321 N.W. 75 Street, Medley, Florida 33166.

### RECITALS

WHEREAS, by an Assignment of Trademarks executed on April 1, 2006, WDLP transferred to Mapalé all of its right, title and interest in and to the trademark, service mark and trade name WDLP-TV (collectively, the "Mark") and Application Serial No. 76/547,495 filed with the U.S. Patent and Trademark Office for registration of the Mark (the "Application"), which subsequently matured into U.S. Registration No. 3,073,984 (the "Registration"); and

WHEREAS, by the same Assignment of Trademarks, WDLP Licensed Subsidiary, LLC, Sonia Broadcasting Company, LLC, and Sonia Licensed Subsidiary, LLC transferred to Mapalé all such right, title and interest as each of them owned or claimed in the Mark and the Application; and

WHEREAS, WDLP wishes to re-acquire the Mark and acquire the Registration and Mapalé wishes to grant WDLP such assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and intending to be legally bound, the parties hereto agree as follows:

### TERMS

1. Quitclaim Assignment of Trademark. Mapalé hereby sells, assigns, transfers and sets over to WDLP all such right, title and interest as Mapalé has, if any, in and to the Mark and the Registration, together with the goodwill, if any, the same to be held and enjoyed by WDLP, its successors, assigns and other legal representatives.
2. Disclaimer of Warranties and Representations. Mapalé makes no representation or warranty as to the existence or condition of its right, title, or interest in the Mark or the goodwill pertaining to the Mark. However, Mapalé acknowledges that as between itself and WDLP, WDLP is the owner of all of the rights hereby transferred, free and clear of any security interest or lien thereon given by Mapalé.
3. Parties in Interest. This assignment shall bind Mapalé, its successors and/or assigns, and all others acting by, through, with or under its direction, and all those in privity therewith; and shall inure to the benefit of WDLP, its successors and assigns.


