RELEASE OF COLLATERAL ASSIGNMENT OF TRADEMARKS

BE IT KNOWN THAT:

WHEREAS, to secure payment of its obligations under a certain Amended and Restated Secured Promissory Note Agreement dated as of July 31, 1999, by and between SCHICK TECHNOLOGIES, INC., a Delaware corporation and DVI FINANCIAL SERVICES, INC., a Delaware corporation (the "Note"), SCHICK TECHNOLOGIES, INC. (as "Assignor") pledged to DVI FINANCIAL SERVICES, INC. (as "DVI") certain intellectual property assets including, inter alia, the U.S. trademarks and trademark registrations set forth on Exhibit A hereto (the "Trademarks") under that certain Collateral Assignment of Patents, Trademarks Copyrights, Licenses and Trade Secrets (the "Collateral Assignment") by and between Assignor and DVI dated as of July 31, 1999 and recorded in the United States Patent and Trademark Office on September 20, 1999 commencing at Reel/Frame: 002008/0710;

WHEREAS, DVI transferred all of its right, title and interest in and to, inter alia, the Note and the Collateral Assignment to GREYSTONE FUNDING CORPORATION, a Virginia corporation ("Assignee"), effective as of August 28, 2000, and DVI subsequently dissolved on March 31, 2005;

WHEREAS, Assignor's "Obligations" (as defined in the Collateral Assignment) have now been fully paid and discharged.

NOW THEREFORE, for good and valuable consideration the receipt and sufficiency of which as hereby acknowledged, Assignee does hereby release, satisfy, terminate and discharge the pledge to Assignor of, and its security interest in, the Trademarks as pledged under the Collateral Assignment, together with that part of the goodwill of the business connected with the use of and symbolized by the Trademarks.
