Trebla Chemical Company originally acquired the above registrations; and at the time of securing the above registrations was wholly owned by CPAC, INC., a New York corporation, whose principal place of business is 2364 Leicester Road, Leicester, New York 14481;

In 2005, Trebla Chemical Company, with all of its assets, including the above trademark registrations, together with the goodwill represented by the marks, was merged into CPAC, INC.

CPAC, INC. as the successor to the merger of Trebla then transferred the above trademark registrations, together with the goodwill represented by the marks, to ALLIED DIAGNOSTIC IMAGING RESOURCES, INC., a Delaware corporation and a wholly owned subsidiary of CPAC, INC., ALLIED DIAGNOSTIC IMAGING RESOURCES, INC. continues using the marks under the d/b/a of CPAC IMAGING, and under the supervision of CPAC, INC.

The above registrations are now subject of a Security Interest to Fifth Street Mezzanine Partners III, L.P.
