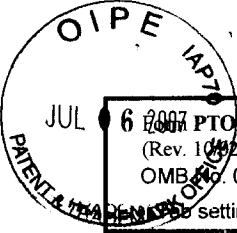

RELEASE OF SECURITY AGREEMENT

THIS RELEASE dated as of **June 28, 2007** (this "Release") is made by U.S. Bank National Association, a National Association, acting in its capacity as secured party (in such capacity, the "Secured Party") under that certain Amended and Restated Patent, Trademark and License Security Agreement, dated as of **October 25, 2005** and recorded in the records of the United States Patent and Trademark Office (as amended, supplemented or modified and in effect from time to time, the "Security Agreement"), among **Omnium Worldwide, Inc.** (the "Debtor") and the Secured Party;

W I T N E S S E T H:




