INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (this "Assignment"), dated as of July 9, 2007, is made by and among CHEMCONNECT, INC., a Delaware corporation ("ChemConnect"), CHEMATCH.COM, INC., a Delaware corporation ("CheMatch"), CHALKBOARD, INC., a Delaware corporation ("Chalkboard"), CHEMATCH.COM DELAWARE1, INC., a Delaware corporation ("CheMatch Delaware") (ChemConnect, CheMatch, Chalkboard and CheMatch Delaware are referred to herein individually as, an "Assignor" and collectively as the "Assignors"), and ChemConnect, as representative of the Sellers (the "Assignors' Representative") and INTERCONTINENTAL EXCHANGE, INC., a Delaware corporation (the "Assignee").

WHEREAS, Assignors own certain right, title, and interest in and to certain Intellectual Property (as defined in the Purchase Agreement) which is a part of the Assets as defined in the Asset Purchase Agreement, dated as of May 31, 2007 entered into among Assignors and Assignee (the "Purchase Agreement"), including such Intellectual Property acquired through merger with or acquisition of previous owners of said Intellectual Property; and enter into this Assignment to transfer to Assignee said Intellectual Property, which includes but is not limited to the Intellectual Property assets identified in Exhibit A attached hereto ("the Assigned IP"); and

WHEREAS, Assignee desires to purchase or acquire all of Assignors' right, title and interest in and to the Assigned IP.

NOW, THEREFORE, in consideration of, among other things, the payment by Assignee of \$1.00 to Assignors and other good and valuable consideration, including any monies paid to Assignors in connection with Assignee's purchase of certain assets of Assignors pursuant to the terms and conditions of the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, Assignors and Assignee agree as follows:

1. Assignment of Trademarks. Assignors, intending to be legally bound, do hereby sell, transfer, convey, assign, and deliver to Assignee and Assignee accepts all right, title, and interest of Assignors in and to (i) the trademarks set forth as part of the Assigned IP; (ii) the registrations and applications for registrations thereof; (iii) all income, royalties, fees, damages, and payments now or hereafter due or payable in respect thereto, and in and to any and all causes of action (either in law or in equity), and the right to enforce any rights and file any causes of action, including the right to recover damages, for any past, present, or future infringement or
