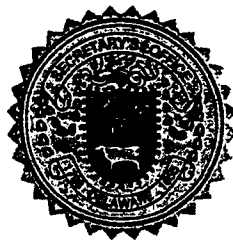

The undersigned, being president and secretary of Miltex, Inc., a Delaware corporation (the "Surviving Corporation") pursuant to Section 252 of the Delaware General Corporation Law (the "DGCL"), does hereby certify that:

FIRST: The constituent corporations are Miltex, Inc., a New York corporation ("Miltex-NY") and Miltex, Inc., a Delaware corporation and wholly owned subsidiary of Miltex-NY ("Miltex-DE"), New York corporations.

SECOND: The Agreement of Merger has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8 Section 252 of the General Corporation Law of the State of Delaware.

THIRD: The Resolution of the Board of Directors of Miltex-DE, dated December 29th, 2005, approving the Agreement and Plan of Merger (the "Merger Agreement") to merge Miltex-NY into Miltex-DE, with Miltex-DE as the Surviving entity is annexed hereto as Exhibit A.

FOURTH: Miltex-NY is authorized to issue 30,000 shares with a par value of \$.010. As of the effective time of the Merger, each of the 30,000 shares with a par value of \$.010 of Miltex-NY which are issued and outstanding immediately prior to the effective time, by virtue of the merger and without any action on the part of the holder thereof automatically shall be converted to one (1) share of the Surviving Corporation.

FIFTH: The Certificate of Incorporation of Miltex-DE shall be the Certificate of Incorporation of the Surviving Corporation.

SIXTH: The Agreement of Merger is on file at 289 Davics Drive, York, PA 17402, an office of the surviving corporation.

SEVENTH: A copy of the Agreement of Merger will be furnished by the surviving corporation on request, without cost, to any stockholder of the constituent corporation.
