TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (“Trademark Assignment”) is made and entered into as of this 3rd day of July, 2007, by and between ALSCO INC., a Nevada corporation (“Assignor”) and COMPUTER SOFTWARE ARCHITECTS, LLC, a Maine limited liability company (“Assignee”).

WHEREAS, Assignor owns all right, title, and interest in, to, and under the Trademarks (defined below) listed on Schedule A; and

Pursuant to and in compliance with the Asset Purchase Agreement, Assignor does hereby sell, assign, transfer, convey, quitclaim and deliver unto Assignee (i) all of Assignor’s right, title and interest (including, without limitation, all intellectual property rights) in and to the trademarks, service marks, trade names and logos (collectively, the “Trademarks”) listed on Schedule A attached hereto and incorporated herein by this reference, including any and all registrations and applications for registration therefor, (ii) all goodwill associated with the Trademarks, and (iii) all rights to sue for and recover damages and profits, due or accrued, and other remedies in respect of any and all past, present and future infringements or misappropriation of the Trademarks, or injury to the goodwill associated with the Trademarks, in perpetuity (or for the longest period of time otherwise permitted by law) and all goodwill generated thereby shall be the sole property of Assignee and inure to the benefit of Assignee.

This Trademark Assignment shall be governed by and construed in accordance with the laws of the laws of the United States of America and the laws of the State of Utah, without regard to its conflict of law principles.

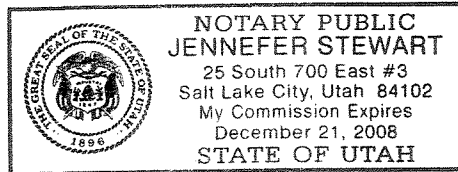


