RELEASE OF TRADEMARK COLLATERAL

THIS RELEASE OF TRADEMARK COLLATERAL (this "Release") is made as of July 12, 2007, by BAL Global Finance, LLC, as successor-in-interest to Sanwa Business Credit Corporation ("Releasing Party"), the secured party under that certain Security Agreement referred to below.

WITNESSETH:

WHEREAS, Skateboard World Industries, Inc., a California corporation doing business as i.e. distribution ("Borrower"), executed that certain Security Agreement (the "Security Agreement") dated as of October 22, 1998, pursuant to which Borrower granted a security interest to Releasing Party in certain trademarks and other intellectual property of Borrower; and

WHEREAS, pursuant to the Security Agreement, a Grant of Security Interests Trademarks (the "Security Interest Notice") was recorded with the Assignment Branch of the United States Trademark Office on October 30, 1998 at Reel 1808, Frame 0233; and

WHEREAS, Releasing Party has agreed to release all its rights under the Security Agreement and the Security Interest Notice, including, without limitation, in the trademarks and applications therefor identified on Exhibit A attached hereto and made a part hereof (the "Released Collateral"), and to reconvey any and all rights in the Released Collateral to Borrower.

NOW, THEREFORE, in consideration of the promises and other good and valuable consideration, receipt of which is hereby acknowledged, Releasing Party hereby releases all its rights in and to the Released Collateral, reconveys to the persons legally entitled thereto all of Releasing Party's right, title and interest in and to the Released Collateral, releases all other rights it may have under the Security Agreement and the Security Interest Notice with respect to the Released Collateral and cancels the Security Agreement and the Security Interest Notice in their entirety, all without warranty or representation of any kind.

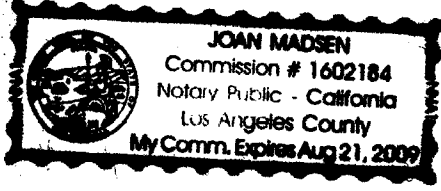
