FIRST: The Company is incorporated pursuant to the General Corporation Law of the State of Delaware (the "DGCL"). The Subsidiary is incorporated pursuant to the DGCL.

SECOND: The Company owns all of the outstanding shares of each class of capital stock of the Subsidiary.

SIXTH: This Certificate of Ownership and Merger, and the Merger provided for herein, shall become effective at 11:59 p.m. on June 30, 2007.
