RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this "Release") is made as of June 25, 2007 ("Effective Date") by and between SHC Ambeo Acquisition Corp. ("Grantor") and Sand Hill Capital Holdings, Inc. ("Grantee").

WHEREAS, pursuant to the terms and conditions of that certain Intellectual Property Security Agreement by and between Grantor and Grantee Agent dated May 17, 2001 (the "Intellectual Property Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all intellectual property listed on Schedule A, including (a) all trademark registrations and pending registrations owned or controlled by Grantor or licensed to Grantor, (b) all patents and patent applications owned or controlled by Grantor or licensed to Grantor, (c) all of Grantor's software, computer programs and other works of authorship subject to United States copyright protection (other than off-the-shelf software licensed to Grantor on an on-exclusive basis), including, without limitation, those for which the sale, licensing or other disposition results in royalties receivable, license fee s receivable, accounts receivable or other sums owing to Grantor (collectively, the "Intellectual Property").

WHEREAS, Grantor and Grantee entered into the Intellectual Property Security Agreement pursuant to the terms and conditions of that certain Loan Agreement by and between Grantor and Grantee dated May 17, 2001 (the "Credit Agreement");

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on (a) May 24, 2001 at Reel/Frame 2305/0612, and (b) on March 27, 2002 at Reel/Frame 2481/079 and with the United States Copyright Office ("USCO") on July 6, 2001 at Volume 3471, Page 641 and on May 24, 2001 at Volume 3469, Page 787; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Intellectual Property Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Intellectual Property.

Grantee shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
