TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT dated as of July 11, 2007 (the "Effective Date") between Tactical Footwear, LLC, a Vermont limited liability company with its principal place of business at 75 Boyer Circle, Williston, Vermont 05495 ("Assignor"), and Garmont NA, Inc., a Vermont corporation with its principal place of business at 170 Boyer Circle, Williston, Vermont 05495 ("Assignee").

WHEREAS, pursuant to that certain Asset Assignment Agreement dated July 11, 2007, between Assignor and Assignee (the "Assignment Agreement"), Assignor has agreed to assign to Assignee its entire right, title and interest in and to the trademarks and trademark registrations set forth below (collectively, the "Marks"), and the goodwill of the business associated with the Marks;

NOW THEREFORE, for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee its entire right, title and interest in and to the Marks together with the goodwill of the business associated with the Marks, include all registrations and applications therefor, as well as all renewals and extensions of registrations that are or may be secured by Assignee, its successors, assigns or other legal representatives, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Assignor if this assignment and sale had not been made, together with all income, royalties, damages or payments due or payable as of the Effective Date or thereafter including, without limitation, all claims for damages by reason of past, present and future infringement or other unauthorized use of the Marks, with the right to sue for damages, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. Assignor authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any country or countries foreign to the United States, whose duty it is to register trademarks, to record Assignee as the assignee and owner of the Marks.

and holding by Assignee, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by Assignor had this sale and assignment not been made, including the right to sue for infringement occurring prior to the execution date of the Assignment.
