ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY, made and having an Effective Date as of the opening of business on July 10, 2007, by and between CABLE TECH GLOBAL LP, a Massachusetts Limited Partnership, ("Assignee"), and Southwire Canada Company ("Assignor").

WITNESSETH

WHEREAS, Assignor has agreed to convey to Assignee all of Assignor's rights in those registered trademarks and service marks and pending applications therefor: and

WHEREAS, Assignee wishes to acquire such Intellectual Property Rights;

NOW, THEREFORE, in consideration of the mutual agreements and provisions contained herein and other good and valuable consideration, the mutual receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the parties hereto do hereby agree as follows:

1. Assignor hereby sells, transfers, assigns, releases and sets over to Assignee, effective as of the Effective Date of this Agreement, all of Assignor's right, title and interest in and to said Intellectual Property Rights, together with the rights attendant thereto, TO HAVE AND TO HOLD the same unto Assignee, its successors and assigns, from and after the date hereof, forever. Assignor acknowledges and agrees that Assignor shall have no right to use or affix to its products such Intellectual Property Rights or any trade name, service mark or trade mark substantially similar to the CableTech trade name and trademark in connection with any products produced on or after the date hereof.

2. At the further request of Assignee, Assignor shall cooperate with Assignee and execute all further necessary documents prepared by Assignee for recording or otherwise formally perfecting transfer of title to Assignee in said rights. Assignee shall record such documents at its own expense to the extent that such recording is deemed necessary by Assignee.

IN WITNESS WHEREOF, Assignor has caused this ASSIGNMENT OF INTELLECTUAL PROPERTY to be executed in duplicate by its duly authorized representative, effective as of the date first above written.

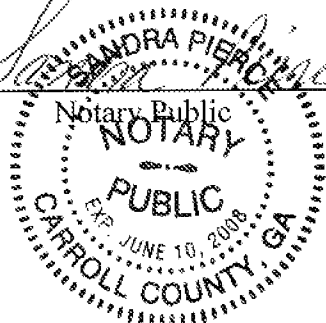
