TRADEMARK ASSIGNMENT

Assignor agrees to perform, at Assignee's expense, all acts and to execute all documents necessary for Assignee to perfect its ownership in and to the Assigned Marks.

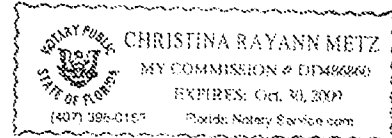

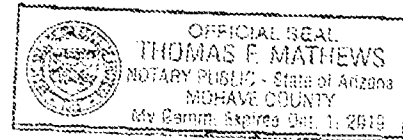

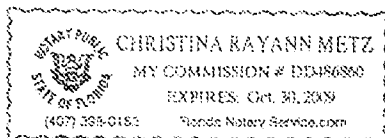
