**RELEASE OF SBRG SUBSIDIARY  
TRADEMARK SECURITY AGREEMENT**

This Release of SBRG Subsidiary Trademark Security Agreement (this "Release"), dated as of July 16, 2007, is entered into between BNP PARIBAS, a bank organized under the laws of France acting through its Chicago branch, located at 209 South LaSalle, Suite 500, Chicago, IL 60604, acting in its capacity as agent for itself and the Secured Parties (together with its successors and assigns, the "Assignor") and LA SALSA, INC. a Delaware corporation located at 6307 Carpinteria Avenue, Suite A, Carpinteria, CA 93013 (with a mailing address of 6307 Carpinteria Avenue, Suite A, Carpinteria, CA 93013) ("Assignee"). Capitalized terms not defined herein shall have the meanings set forth in the Fourth Amended and Restated Subsidiary Security Agreement, dated as of June 2, 2004, among the Assignee, other assignees thereunder, and the Assignor (as amended, restated, supplemented, or otherwise modified from time to time, the "Subsidiary Security Agreement").

WHEREAS, pursuant to the Subsidiary Security Agreement, Assignee granted a security interest to the Assignor in certain Collateral, including the Trademarks;

WHEREAS, in connection with the Subsidiary Security Agreement, Assignee entered into that certain (i) SBRG Subsidiary Trademark Security Agreement, dated as of April 30, 2003 (the "April 2003 Trademark Security Agreement"), (ii) Amended and Restated SBRG Subsidiary Trademark Security Agreement, dated as of November 12, 2003 ("Amended Trademark Security Agreement"), and (iii) Second Amended and Restated SBRG Subsidiary Trademark Security Agreement, dated as of June 2, 2004 (the "Second Amended Trademark Security Agreement"), each in favor of the Assignor (collectively, as each has been amended, restated, supplemented or otherwise modified prior to the date hereof, the "Trademark Security Agreements");

WHEREAS, the April 2003 Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on August 13, 2002 at reel 2526, frame 0968; the Amended Trademark Security Agreement was recorded with the PTO on January 13, 2004 at reel 2777, frame 0391; and, the Second Amended Trademark Security Agreement was recorded with the PTO on June 10, 2004 at reel 2870, frame 0073; and

WHEREAS, Assignor has entered into a Release, dated July 16, 2007, whereby Assignor released and re-conveyed to Assignee all of its right, title and interest in and to the trademarks of Assignee described in Exhibit A hereto, including from the lien, security interest or other encumbrances under the Trademark Security Agreement.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficient of which are hereby acknowledged, the Assignor hereby releases all of its right, title and interest in and to the trademarks of Assignee described in Exhibit A hereto, and Assignor hereby terminates, releases, re-conveys, and reassigns to Assignee all of its right, title and interest of any kind or nature in, to, and under such trademarks.

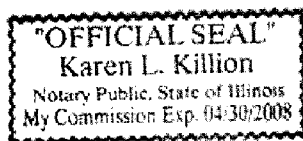
