## CONFIRMATORY ASSIGNMENT OF TRADEMARKS

By IFMG-IP, LLC., a Virginia limited liability company ("IFMG-IP"), in favor of DOMINION ENTERPRISES, a Virginia general partnership ("Dominion"), this 31<sup>st</sup> day of May, 2007.

Pursuant to an Asset Purchase Agreement executed by the parties on May 31, 2007 (the "Grant Date"), IFMG-IP conveyed its ongoing and existing automotive financing lead-generation business to Dominion, along with all related trademarks and/or service marks that are registered in or the applications for which are pending with the United States Patent and Trademark Office, described in Exhibit A (the "Marks"), all right, title, and interest to which were held by IFMG-IP. The parties desire to confirm such conveyance by this Confirmatory Assignment.

IFMG-IP therefore states as follows:

1. IFMG-IP hereby confirms that it has assigned to Dominion, its successors and assigns, from and after the Grant Date, its entire right, title and interest in the Marks and their accompanying goodwill, including, without limitation:
  - a all renewals thereof;
  - b all proceeds therefrom, including, without limitation, all income, royalties, damages, and payments now and hereafter due and/or payable under and with respect thereto, including (without limitation) damages and payments for past or future infringements thereof;
  - c the right to sue and recover for past, present, and future infringements thereof; and
  - d all rights corresponding thereto and throughout the United States.
2. This assignment remains subject to the terms and conditions contained in the Asset Purchase Agreement.
3. The assignment of all Marks applied for on an intent-to-use basis is an assignment to a successor of a portion of IFMG-IP's business, which is ongoing and existing, as authorized by 15 U.S.C. § 1060(a)(1).
4. This assignment applies to the Marks in the United States and throughout the world.
