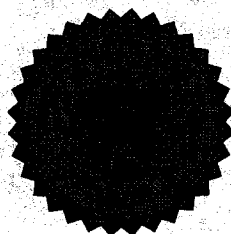

**FIRST:** The name and the domicile of each constituent entity is:
