**MEMORANDUM OF SECURITY INTEREST**  
**IN UNITED STATES TRADEMARKS**

WHEREAS, Trademark Owner and Fifth Third Bank, a Michigan banking corporation (the "Bank"), are parties to a certain Security Agreement dated May 30, 2007 together with any and all amendments now or hereafter made thereto, (herein referred to as the "Security Agreement") which provides for the grant by Trademark Owner to Bank of a continuing security interest in certain of Trademark Owner's assets including, without limitation, the Trademark Rights.

NOW, THEREFORE, Trademark Owner hereby executes this Memorandum of Security Interest in United States Trademarks for the purpose of placing the world on notice of the existence of the security interest in the Trademark Rights that is held by the Bank pursuant to the Security Agreement.
