Agreement is made this 26th day of JUNE, 2007 by and between King Raymond Green for Powerhouse Productions, 2650 Rock Creek Drive, Dover Pennsylvania 17315. (Hereinafter referred to as "Trademark Owner") and Charles R. Stevens A.K.A. Steve Charles 1703 Irving Street N.E. Washington, D.C. 20017 or P.O. Box 80171 Washington, D.C. 20018 and Johnny Mason 1821 18th Street Apt.1 S.E. Washington, D.C. 20020 (Hereinafter referred to as "Partners").

- 1. The Trademark Owner hereby grants and Partners engages in Trademark Owner exclusive personal services in connection with the production of live and recorded musical entertainment.
- 2. The Trademark Owner agrees to give the Partners 100% (Charles R. Stevens A.K.A Steve Charles 50%, and Johnny Mason 50%) sole and exclusive right to use the U.S. Trademark, "The Clovers" domestically and internationally. The Trademark Owner agrees that the Partners may use the Trademark "The Clovers" for all forms of live and recorded musical entertainment, which includes but is not limited to; concerts, cabarets, recording sessions, television shows, radio shows, weddings, private events, fund raisers, etc.
- 3. This contract shall be a binding permanent lifetime agreement between the Trademark Owner and the Partners, commencing at the signing of this agreement.
- 4. In the case of death of Charles R. Stevens A.K.A Steve Charles, his proportionate share of the Partners shall become the property King Raymond Green of Powerhouse Productions 2650 Rock Creek Drive, Dover Pennsylvania, 17315. This agreement may not be modified in any way unless agreed to, signed and notarized by both parties and accompanied by a completed U.S.Trademark Recordation form 1594.
- 5. Illegality or unenforceability or any portion hereof shall not affect the legality or enforceability of the balance of this Agreement.
