TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, JSI Industries, Inc. ("Assignor"), a corporation of the State of Wisconsin, is the owner of those trademarks (the "Marks") listed on the attached Schedule A, together with those registrations (the "Registrations") therefor listed on the Schedule A; and

NOW, THEREFORE, for good and valuable consideration, the receipt of which Assignor hereby acknowledges, Assignor hereby agrees to and does sell, assign and transfer to Assignee its entire right, title and interest in and to the Marks and the Registrations, together with the goodwill of the business to which the Marks pertain, as well as all rights of enforcement and recovery for past infringement. Assignor further agrees, at Assignee's expense, to take all reasonable and necessary steps to implement the provisions of this assignment.
