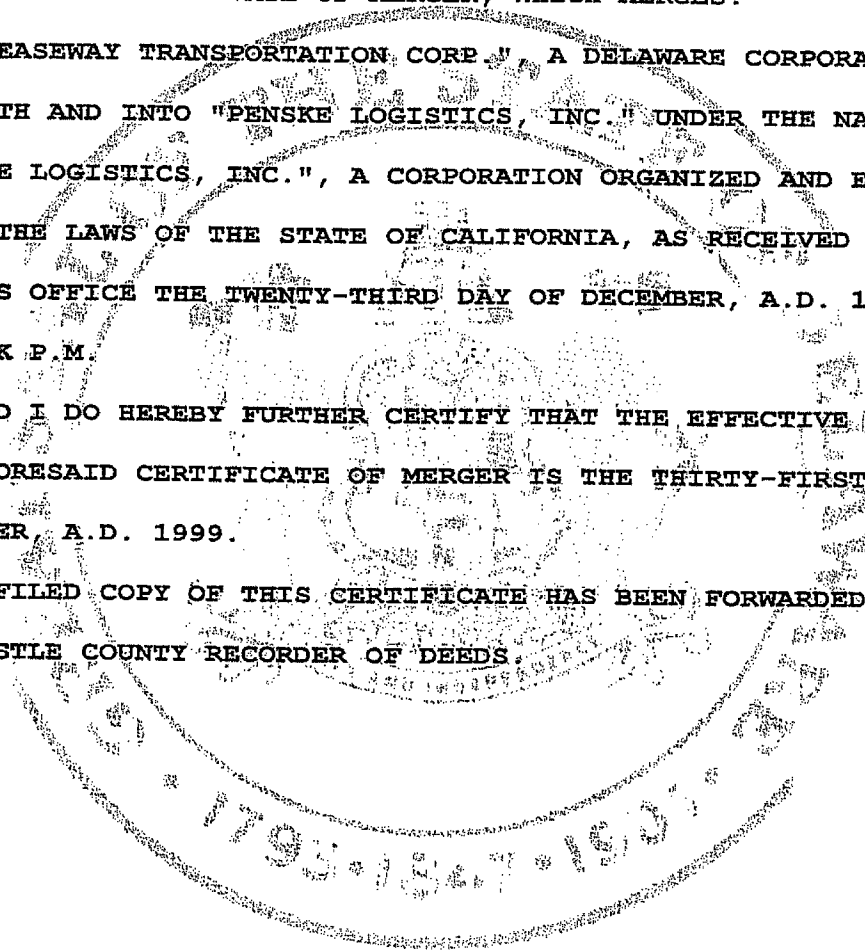

DOES HEREBY CERTIFY:

FIRST: That the names and states of incorporation of each of the constituent corporations to the merger are as follows:

SECOND: That a Plan and Agreement of Merger among the parties to the merger has been approved, adopted, certified, executed, and acknowledged by each of the constituent corporations in accordance with the requirements of Section 252 of the Delaware General Corporation Law.

SIXTH: That a copy of the Plan and Agreement of Merger will be furnished, on request and without cost, to any stockholder of any constituent corporation.

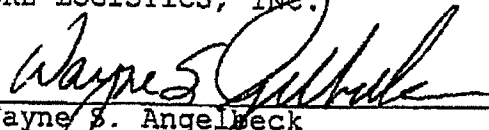
