**LIMITED TERMINATION AND RELEASE OF
TRADEMARK COLLATERAL ASSIGNMENT**

This LIMITED TERMINATION AND RELEASE ("Termination and Release") is dated July 17, 2007 and made by Marquette Business Credit, Inc., a Minnesota Corporation ("Lender"), successor in interest to Capital Tempfunds, Inc., a North Carolina Corporation, and Amerijet Central America, LLC, a Florida limited liability company ("Grantor").

WITNESSETH

WHEREAS, on November 18, 2003, Grantor and Lender entered into a Continuing Guaranty and Waiver and Amended and Restated Loan and Security Agreement (collectively, with any subsequent amendments, the "Security Agreements"), pursuant to which the Lender agreed to make certain loans and provide other financial accommodations to Grantor upon the terms and conditions stated therein;

WHEREAS, the Grantor executed and delivered a Trademarks Collateral Assignment (the "Collateral Assignment") to the Lender on November 18, 2003, as required by the Lender as a condition of the Security Agreements;

WHEREAS, the Collateral Assignment was recorded with the United States Patent and Trademark Office on November 25, 2003, at Reel 2869/Frame 0142;

WHEREAS, the Grantor has requested that Lender terminate the Collateral Assignment and release the continuing security interests in the specific Trademarks (as defined below), which Grantor had previously granted to the Lender so that Grantor may assign such Trademarks (as defined below); and

NOW, THEREFORE, in consideration of the premises set forth herein and for other good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby terminates and releases the security interests in the Trademarks, as follows:

1. The Lender hereby terminate and release its security interests in Grantor's registered trademarks and common law trademarks identified on Schedule A, attached hereto and made a part hereof (the "Trademarks"), including, without limitation, the goodwill of the business to which each of the Trademarks relates, all proceeds of the Trademarks (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present, and future infringements, all rights corresponding thereto throughout the world, and all renewal thereof; and
2. Except as set forth in this Limited Termination and Release, the Collateral Assignment shall remain in full force and effect.
