PATENT AND TRADEMARK RELEASE AND REASSIGNMENT

THIS PATENT AND TRADEMARK RELEASE AND REASSIGNMENT is made as of July 3, 2007, by WELLS FARGO BANK, NATIONAL ASSOCIATION ("WELLS FARGO"), successor in interest to Wells Fargo Credit, Inc. f/k/a Norwest Credit, Inc., ("NORWEST").

W I T N E S S E T H:

WHEREAS, NORWEST and WORKRITE ERGONOMICS, INC., a Delaware corporation ("WORKRITE"), fka Workrite Ergonomic Accessories, Inc., were parties to that certain Patent and Trademark Security Agreement dated as of February 1, 1999 (the "Security Agreement"), pursuant to which WORKRITE granted a security interest to NORWEST in the Collateral (as defined in the Security Agreement) as security for certain obligations owing by WORKRITE to NORWEST, including, without limitation, the Patents and Trademarks (as defined in the Security Agreement) (and intellectual property relating to same) set forth on Exhibit A and Exhibit B hereto (the "Patent and Trademark Collateral"); and

WHEREAS, NORWEST and WORKRITE recorded such security interest in the Assignment Division of the United States Patent and Trademark Office on March 30, 1999 at Reel 1876, Frame 0062 (trademarks) and Reel 9843, Frame 0978 (patents); and

WHEREAS, Norwest Credit, Inc. changed its name to "Wells Fargo Credit, Inc." and has conveyed all of its right, title and interest in the Security Agreement to WELLS FARGO; and

WHEREAS, WORKRITE has requested that WELLS FARGO release its security interest in the Patent and Trademark Collateral;


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. WELLS FARGO hereby releases its security interest in and to all of the Patent and Trademark Collateral, including without limitation the patents and trademark registrations referred to in Exhibit A and Exhibit B annexed hereto, and the goodwill of WORKRITE's business connected with the use of and symbolized by such patents and trademarks.

2. WELLS FARGO hereby reassigns, grants and conveys to WORKRITE, without any representation, warranty, recourse or undertaking by WELLS FARGO, all of WELLS FARGO's right, title and interest in and to the Patent and Trademark Collateral, including without limitation the patents and trademark registrations referred to in Exhibit A and Exhibit B annexed hereto and the goodwill of WORKRITE's business connected with the use of and symbolized by such patents and trademarks.
