TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

July 25 This Termination and Release of Security Interest, (this "Release") dated as of July 25, 2007, made by UBS AG, Stamford Branch, as Collateral Agent (the "Collateral Agent"), in favor of Internetwork Publishing Corporation ("Internetwork").

RECITALS:

SECTION 1.1. Collateral Agent recorded a security interest as to trademarks and trademark applications with the Trademark Division of the United States Patent & Trademark Office on October 19, 2006, at Reel 003411, Frame 0967.

SECTION 1.2. Internetwork has requested Collateral Agent to release, and Collateral Agent has agreed to release, its lien on such trademarks and trademark applications.
