**RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE, dated as of May 31, 2007, is made by GOLDMAN SACHS CREDIT PARTNERS L.P., as collateral agent (in such capacity, the "Collateral Agent"), pursuant to the termination of the Second Lien Credit Agreement, dated as of September 29, 2006 (the "Credit Agreement"), by and among IPC Systems, Inc., a Delaware corporation formerly known as IPC Information Systems, LLC (the "Borrower"), Trader Acquisition Corp ("Holdings"), the lenders party thereto from time to time, Goldman Sachs Credit Partners L.P., as co-lead arranger, joint bookrunner, co-syndication agent, administrative agent (in such capacity, the "Administrative Agent") and Collateral Agent, J.P. Morgan Securities Inc., as co-lead arranger and joint bookrunner, Morgan Stanley Senior Funding, Inc., as joint bookrunner and co-syndication agent, and JPMorgan Chase Bank, N.A., as co-syndication agent, and that certain Second Lien Security Agreement, dated as of September 29, 2006 (as amended, supplemented, replaced or otherwise modified from time to time, the "Security Agreement"), by and among the Borrower, certain subsidiaries of the Borrower (together with the Borrower, the "Grantors") and the Collateral Agent. Capitalized terms not otherwise defined herein have the meanings set forth in the Security Agreement.

**W I T N E S S E T H**

WHEREAS, pursuant to the Second Lien Patent Security Agreement, dated as of September 29, 2006 ("Patent Security Agreement"), by and among the Grantors and the Collateral Agent, recorded with the U.S. Patent and Trademark Office on November 30, 2006 at Reel/Frame Nos. 18563/0447 and 18563/0461, each Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of such Grantor's right, title and interest in and to the Patents, including, without limitation, those Patents listed on Schedule I hereto;

WHEREAS, pursuant to the Second Lien Trademark Security Agreement, dated as of September 29, 2006 ("Trademark Security Agreement"), by and among the Grantors and the Collateral Agent, recorded with the U.S. Patent and Trademark Office on November 30, 2006 at Reel/Frame Nos. 3436/0061 and 3436/0138, each Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of such Grantor's right, title and interest in and to the Trademarks, including, without limitation, those Trademarks listed on Schedule I hereto;

WHEREAS, pursuant to the Second Lien Copyright Security Agreement, dated as of September 29, 2006 ("Copyright Security Agreement"), by and among the Grantors and the Collateral Agent, each Grantor granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to all of such Grantor's right, title and interest in and to the Copyrights, including, without limitation, those Copyrights listed on Schedule I hereto;

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in the Intellectual Property in connection with the termination of the Credit Agreement and the Security Agreement;

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby RELEASES, without recourse, all of its security interest in the Intellectual Property listed on Schedule I attached hereto and incorporated herein by reference (the "Released Collateral") to the Grantors.

The Collateral Agent agrees to provide the Grantors with any additional authorization necessary to effect the release of its security interest in the Released Collateral.
