**RELEASE OF SECURITY INTEREST – TRADEMARKS**

WHEREAS, TORONTO DOMINION INVESTMENTS, INC. ("Bank") and AURAFIN LLC, a Delaware corporation ("Aurafin"), are parties to a certain Subordinated Security Agreement, dated as of June 21, 2001, and a certain Amendment to Subordinated Security Agreement dated as of August 16, 2006 (collectively referred to as the "Security Agreements") and pursuant to which Aurafin and its predecessors, including Aurafin-OroAmerica LLC, and other entities Nob Hill Home Creations, LLC, Pippo Worldwide, LLC, and UC Couture, LLC granted to the Bank a security interest in Pledged Trademarks (as defined therein) and provided for the enforcement of such security interest; and

WHEREAS, the Bank desires to: (i) release the security interest in the Pledged Trademarks; (ii) waive all of its rights, title, and interest in such Pledged Trademarks, and restore all such rights, title and interest to the Pledged Trademarks to Aurafin, and (iii) dissolve any and all liens and encumbrances respecting the Pledged Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby releases its security interest in the Pledged Trademarks, terminates the Security Agreements, and releases and relinquishes any and all rights, title, and interest it has in and to the Pledged Trademarks, including, but not limited to, those recorded as referenced on attached Exhibit A, which is made a part of this Release

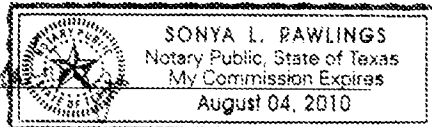
