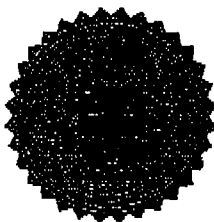

Pursuant to Section 252 of the Delaware General Corporation Law (the "DGCL"), the undersigned corporation hereby certifies as follows:

1. The constituent corporations are Inkadinkado, Inc., a corporation organized and existing under the laws of the Commonwealth of Massachusetts, and Inkado, Inc., a corporation organized and existing under the laws of the State of Delaware.
2. An Agreement of Merger (the "Agreement of Merger") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations in accordance with Section 252 of the DGCL.
3. Upon consummation of the merger, the name of the surviving corporation will be Inkado, Inc.
4. The Certificate of Incorporation of Inkado, Inc. will be the Certificate of Incorporation of the surviving corporation.
5. An executed copy of the Agreement of Merger is on file at the principal place of business of Inkado, Inc., 61 Holton Street, Woburn, MA 01801.
6. The surviving corporation will furnish a copy of the Agreement of Merger to any of its shareholders, or to any person who was a member of any constituent corporation, upon request and without charge.
7. The authorized capital stock of Inkadinkado, Inc. immediately prior to the consummation of the merger consists of 600,000 shares of common stock, \$.01 par value per share.
