## ASSIGNMENT OF TRADEMARKS



WHEREAS, Purchaser is desirous of acquiring the entire interest of Seller in the Trademarks.


NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Seller by these presents does hereby sell, assign, grant, bargain transfer and deliver unto Purchaser all of its right, title and interest in and to the Trademarks for Purchaser's own use and benefit, and for its successors and assigns, as fully and entirely as the same would have been held by Seller had this Assignment and sale not been made free and clear of any and all contravening rights and equities, liens, encumbrances, security interests and adverse claims except as otherwise provided in such Agreement. Seller binds itself to warrant and forever defend title to all properties herein transferred, against every person whomsoever lawfully claiming or to claim infringement or misappropriation of the same or any part thereof.
