RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST, dated as of July 19, 2007, is made by General Electric Capital Corporation (“*GECC*”), in its capacity as agent (the “*Collateral Agent*”) for the Lenders (as defined in the Credit Agreement (as defined below)) in favor of Bulkmatic Transport Company (the “*Grantor*”).

WHEREAS, the Grantor, an Illinois corporation entered into an Amended and Restated Credit Agreement dated as of February 28, 2005 (as amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the “*Credit Agreement*”), with the other credit parties signatory thereto from time to time, GECC, as agent, and the Lenders party thereto from time to time. Terms defined in the Credit Agreement and not otherwise defined herein are used herein as defined in the Credit Agreement.

WHEREAS, prior to the date hereof, the Grantor and other grantors party thereto executed and delivered that certain Security Agreement dated March 30, 2001 made by the Grantor and the other parties thereto to the Collateral Agent (as amended, amended and restated, supplemented or otherwise modified prior to the date hereof, the “*Security Agreement*”).

WHEREAS, under the terms of the Security Agreement, the Grantor has granted to the Collateral Agent, for the benefit of the Lenders, a security interest in, among other property, certain intellectual property of the Grantor.

WHEREAS, an assignment of trademark security interest was filed on March 21, 2005 with the U.S. Patent and Trademark Office and the Trademark was recorded at reel/frame no. 3049/0755.

WHEREAS, in accordance with the provisions of the Security Agreement, the Collateral Agent is willing to terminate and discharge fully its security interest in the Grantor’s intellectual property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent agrees as follows:

SECTION 1. Release of Security Interest. The Collateral Agent hereby releases, without representation or warranty or recourse of any kind whatsoever, to the Grantor its security interest in all of the Collateral Agent’s right, title and interest in, to and under the Collateral (as defined in the Security Agreement), including, without limitation, the trademark listed on Schedule A hereto.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release of Intellectual Property Security Interest.

SECTION 3. Governing Law. This Release of Intellectual Property Security Interest shall be governed by, and construed in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, the Collateral Agent has caused this Release of Intellectual Property Security Interest to be duly executed and delivered by its officer thereunto duly authorized as of the date first above written.
