Whereas, EMSAM, INC. has made application to the United States Patent and Trademark Office to register THE SNEAKY CHEF on the Principal Register; and


Whereas, EMSAM, INC.'s application to register THE SNEAKY CHEF is pending; and

Whereas, THE SNEAKY CHEF, INC. wishes to acquire all rights to the trademark,


