## TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is effective as of this 27th day of July, 2007 (the "Effective Date").

2. Assignee is to hold all right, title and interest in and to the Assigned Trademarks as fully and exclusively as it would have been held and enjoyed by Assignor had the assignment in this Assignment not been made.

3. This Assignment shall be deemed effective as between the parties as of the Effective Date. Assignor will, without additional consideration, take such further actions and execute promptly such further documents as may be reasonably requested by Assignee, at Assignee's expense, to transfer, vest, record and perfect Assignor's rights, title and interest in and to the Assigned Trademarks and the related rights in Section 1 in Assignee. Assignor hereby authorizes Assignee to request the United States Patent and Trademark Office to record Assignee as the assignee and owner thereof.

4. This Assignment may be executed in several counterparts, each of which shall be deemed to be an original, and all of which together shall be deemed to be one and the same instrument.
