TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Trademark Assignment"), effective as of July 30, 2007, is made among Famous Music LLC, a Delaware limited liability company ("Famous"), Viacom International Inc., a Delaware corporation ("VII"), and Famous Music One LLC, a Delaware limited liability company ("FM One").

WHEREAS, Famous owns all worldwide right, title and interest in and to the trademarks, trademark registrations and trademark applications set forth on Schedule 1 hereto, including all common law rights and together with all goodwill associated with any of the foregoing (the "Marks");

WHEREAS, Famous has entered into resolutions to assign the Marks to VII and FM One;

WHEREAS, FM One has entered into resolutions to assign the Marks to VII;

WHEREAS, VII and FM One desire to acquire pursuant to, and Famous wishes to make, a distribution-in-kind of all worldwide right, title and interest in and to the Marks;

WHEREAS, VII desires to acquire pursuant to, and FM One wishes to make, a distribution-in-kind of FM One's interest in all worldwide right, title and interest in and to the Marks; and

WHEREAS, the parties desire to execute this Trademark Assignment for purposes of transferring the Marks and filing this Trademark Assignment with the United States Patent and Trademark Office, as well as any other state or foreign offices in which filings are to be made.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as set forth below:

1. Famous hereby sells, assigns, transfers and conveys to VII and FM One, all right, title, interest in and to the Marks in the United States and throughout the world, including all common law rights and together with the goodwill of the business connected with and symbolized by the Marks (including, without limitation, the right to renew any registrations included in the Marks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Marks, and any priority right that may arise from the Marks), the same to be held and enjoyed by VII and FM One as fully and entirely as said interest could have been held and enjoyed by Famous had this sale, assignment, transfer and conveyance not been made.

2. FM One hereby sells, assigns, transfers and conveys to VII, all of FM One's right, title, interest in and to the Marks in the United States and throughout the world, including all common law rights and together with the goodwill of the business connected with and symbolized by the Marks (including, without limitation, the right to renew any registrations included in the Marks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the Marks, and any priority right that may arise from the

Marks), the same to be held and enjoyed by VII as fully and entirely as said interest could have been held and enjoyed by FM One had this sale, assignment, transfer and conveyance not been made.


3. Famous authorizes the United States Patent and Trademark Office and other empowered officials in any applicable jurisdiction within or outside the United States to record the transfer of the registrations and/or applications for registration or renewal of the Marks VII and FM One as assignees of Famous' entire right, title and interest therein. Famous agrees to further execute any documents reasonably necessary to effectuate this Trademark Assignment or to otherwise confirm VII's and FM One's ownership of the Marks, as directed by VII and FM One.

4. FM One authorizes the United States Patent and Trademark Office and other empowered officials in any applicable jurisdiction within or outside the United States to record the transfer of the registrations and/or applications for registration or renewal of the Marks VII as assignee of FM One's entire right, title and interest therein. FM One agrees to further execute any documents reasonably necessary to effectuate this Trademark Assignment or to otherwise confirm VII's ownership of the Marks, as directed by VII.
