## ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT OF TRADEMARKS is made and entered into as of August 1, 2007, by and among Lucite International, Inc., a Missouri corporation ("LII"), Lucite International Canada, Inc., an Ontario corporation ("Lucite Canada" and together with LII, "Assignors" and each individually, an "Assignor"), and Plaskolite South, LLC, an Ohio limited liability company ("Assignee").

### RECITAL

WHEREAS, LII or Lucite Canada owns the trademarks, United States and foreign applications and registrations therefor and common law rights pertaining thereto related to the Extruded Sheet Business and the Polymer Business set forth on Schedule A attached hereto (collectively, the "Marks");

WHEREAS, Assignors, Assignee and Plaskolite, Inc., an Ohio corporation, are parties to that certain Asset Purchase and New Business Development Agreement, dated August 1, 2007 (the "Agreement"), pursuant to which Assignors agreed to sell, and Assignee agreed to purchase, certain assets of Assignors, including without limitation, the Marks. Pursuant to the Agreement, Assignors have agreed to execute such instruments as the Assignee may reasonably request in order to more effectively assign, transfer, grant, convey, assure and confirm to Assignee and its successors and assigns, or to aid and assist in the collection of or reducing to possession by the Assignee of, all of such assets; and

WHEREAS, this Assignment of Trademarks is being executed and delivered pursuant to Section 6.4(v) of the Agreement.

In accordance therewith, each Assignor desires to transfer and assign to Assignee, and Assignee desires to accept the transfer and assignment of, all of such Assignor's worldwide right, title and interest in, to and under such Assignor's Marks, subject to the terms and conditions set forth herein and in the Agreement.

NOW, THEREFORE, in accordance with the terms of the Agreement, effective as of 12:01 a.m. EDST on August 1, 2007 (the "Effective Time"), each Assignor, for good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, does hereby transfer and assign to Assignee, and, effective as of the Effective Time, Assignee hereby accepts the transfer and assignment of, all of such Assignor's worldwide right, title and interest in, to and under the Marks, together with the goodwill of the business associated therewith and which is symbolized thereby, all rights to sue for infringement of any Mark, whether arising prior to or subsequent to the date of this Assignment of Trademarks, all income, royalties, fees and payments, now or hereafter due in respect of the Marks, and any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States and in any other jurisdiction, the same to be held and enjoyed by the said Assignee, its successors and assigns from and after the date hereof as fully and entirely as the same would have been held and enjoyed by the said Assignor had this Assignment of Trademarks not been made.

Except as otherwise provided in the Agreement, and subject to the representations and warranties contained therein, the Marks conveyed hereunder are transferred without any representation or warranty whether express or implied.

Except to the extent that federal law preempts state law with respect to the matters covered hereby, this Assignment of Trademarks shall be governed by and construed in accordance with the laws of the State of Ohio without giving effect to the principles of conflicts of laws thereof.


