

Instructions for Liability Company Certificate of Amendment/Restatement/Correction

Follow these instructions in this section if an item in box (1) is checked.

(Domestic)

A certificate of amendment filed shall be on a form prescribed by the secretary of state and shall set forth all the following:

- a. The name of the Limited Liability Company;
- b. The date of the filing of the Limited Liability Company's articles of organization that are being amended;
- c. The amendment to the Limited Liability Company's articles of organization.

The certificate of amendment shall be executed by a member, manager, or authorized representative of the Limited Liability Company, which person shall also certify that the person is authorized to execute the certificate. If an Ohio Limited Liability company wishes to change its agent it must file Form # 521 statutory agent update.

Follow these instructions in this section if an item in box (2) is checked.

(Foreign)

If any statement in an application for registration as a Foreign Limited Liability Company is materially false when made or if any fact described in the application have changed making it inaccurate in any material respect, the Foreign Limited Liability Company shall file promptly with the secretary of state a certificate correcting the application that shall be on a form that is prescribed by the secretary of state and be signed by an authorized representative of the company. If the application for registration or a subsequent certificate of correction becomes inaccurate because the designated agent changes the agent address from that appearing in the registration application or any subsequent certificate of correction of the registration application, the Foreign Limited Liability Company, or the designated agent on its behalf, shall file promptly with the secretary of state a new certificate of correction setting forth the new address.
