Onyx Software Corporation, a corporation organized and existing under and by virtue of the Business Corporation Act of the State of Washington (the "Corporation"), DOES HEREBY CERTIFY:

FIRST: That the Board of Directors of the Corporation, by unanimous written consent dated April 30, 2007 in accordance with the provisions of the Business Corporation Act of the State of Washington, duly adopted resolutions setting forth a proposed amendment to the certificate of incorporation of the Corporation and declaring its advisability. The resolution setting forth the proposed amendment is substantially as follows:

"RESOLVED: That the certificate of incorporation of the Corporation be amended to change the corporate name of the Corporation to "Consona CRM Inc."; and that such name change be effected by filing [REDACTED] of amendment with the Secretary of the State of Washington." articles

THIRD: That the aforesaid amendment to the certificate of incorporation of the Corporation was duly adopted in accordance with the applicable provisions of Sections 07.040 and 10.030 of the Business Corporation Act of the State of Washington.
