Pursuant to the provisions of Section 242 of the General Corporation Law of the State of Delaware, the undersigned corporation adopts the following amendment to its Certificate of Incorporation:

- 1. The name of the corporation is FWI, Inc.
- 2. By unanimous written consent, the board of directors of the corporation duly adopted the following resolutions setting forth a proposed amendment to the Certificate of Incorporation of the corporation, declaring said amendment to be advisable, and directing that the amendment be submitted to the stockholders of the corporation for consideration thereof:

RESOLVED, that the Company's Certificate of Incorporation is amended as follows:

A. ARTICLE ONE is hereby deleted and replaced with the following:

"The name of the corporation is ConnectivHealth, Inc. (the "Corporation")."

3. Thereafter, pursuant to a resolution of the board of directors, the stockholders of said corporation owning the necessary number of shares as required by statute and by the Certificate of Incorporation executed a written consent in favor of the amendment, in accordance with Section 228 of the General Corporation Law of the State of Delaware.
