Assignor does hereby sell, assign and transfer to Assignee, its successors and assigns forever, all of Assignor's right, title, and interest in, to, and under the Mark together with all of the goodwill of the business associated and connected thereby including without limitation (i) any and all original certificates of registration, wherever issued, or other registration rights, including all materials and files related thereto, (ii) any and all pending applications, wherever filed, and all materials and files related thereto, (iii) the right to register, renew and receive certificates of registration and other materials for or related to the Mark, and the right to make any other filing for the Mark such as the right to file Affidavits under Sections 8 and 15 of the Trademark Act of 1946, (iv) the right to sue for past, present or future infringements of the Mark and all rights corresponding thereto throughout the world and the right to retain damages therefrom; and (v) any and all common law rights associated with the Mark; and the same to be held and enjoyed by Assignee, its successors and assigns, for its own use and on behalf and for its successors and assigns.



cause as likelihood confusion or unfair competition, constitute a colorable imitation thereof or to suggest some association between Assignor and Assignee or sponsorship and/or endorsement of Assignor by Assignee.
