TRADEMARK ASSIGNMENT

Assignor will execute and deliver at a future date, without further compensation or other consideration, any documents that Assignee determines may be necessary or desirable to perfect Assignee's ownership of the Marks and effectuate this Assignment or any future

assignment of the Marks from Assignee to a third party, including, but not limited to, executing separate trademark assignment documents for individual countries.

This Assignment may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.

This Assignment shall be construed under and governed by the laws of the State of New Jersey without regard to its conflict of laws provisions or other principles of any jurisdiction that would result in the application of any law other than the laws of the State of New Jersey.
