TRADEMARK AND DOMAIN NAME ASSIGNMENT

THIS TRADEMARK AND DOMAIN NAME ASSIGNMENT (this "Assignment") is made as of June 30, 2007, by and among The Staubach Company, a Texas corporation ("Assignor"), and Roger T. Staubach and Marianne H. Staubach (collectively "Assignee"). (Assignor and Assignee are referenced herein individually as a "Party" and collectively as the "Parties").

WITNESSETH:

WHEREAS, the Parties have entered into that certain Name Assignment and License Agreement dated as of the date hereof (the "Name Assignment Agreement"), pursuant to which, among other things, Assignor sold, assigned, transferred, conveyed, and delivered to Assignee all of Assignor's rights and interests in the Intellectual Property (as defined in the Name Assignment Agreement), including the domain names set forth in **SCHEDULE A** attached hereto (collectively, the "Domain Names") and the trademarks, trade names, and corresponding applications and registrations set forth in **SCHEDULE B** attached hereto (collectively, the "Marks");

WHEREAS, the Parties desire to memorialize the assignment, transfer, and conveyance of the Domain Names and Marks from Assignor to Assignee in a form suitable for recording in the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the Parties agree as follows:

1. **ASSIGNMENT**. Assignor hereby sells, assigns, transfers, conveys, and delivers to Assignee, all of Assignor's rights, title, and interest in, to, and under the Domain Names and the Marks, together with the goodwill associated therewith and in and to all causes of action, either in law or in equity for past, present, or future infringement of the Domain Names and the Marks, and in and to all rights corresponding to the foregoing throughout the world. Such rights, title, and interest shall be held and enjoyed by Assignee, for their own use and benefit and for the use and benefit of their successors and assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made. Notwithstanding the foregoing, Assignor shall retain all income, royalties, damages, claims, and payments now or hereafter due or payable with respect to the Domain Names and the Marks.

2. **FURTHER ASSURANCES**. Assignor shall execute and deliver to Assignee all such further instruments, assignments, assurances, and other documents as Assignee may reasonably request or as may be necessary to more fully assign and convey to and vest in Assignee all rights in and to the Domain Names and the Marks.

3. **CONTROL OF DOMAIN NAMES.** Assignor shall reasonably assist Assignee in transferring control of the Domain Names to Assignee, or their designee, and shall authorize the transfer of the Domain Names from Assignor's present registrar to Assignee's designated registrar or account.

4. **COUNTERPARTS.** This Assignment may be executed in counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement.




