
CONFIRMATORY TRADEMARK ASSIGNMENT



Box 2440, LCD 1 Hamilton, Ontario, Canada L8N 4J6 (hereinafter referred to as the "Assignees") has acquired the entire right, title and interest in and to the Marks, including all of the goodwill of the business in connection with which the Marks are used, pursuant to the Asset Purchase Agreement executed by the parties on October 10, 1997.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor confirms that effective as of October 10, 1997, it assigned, transferred and set over unto Assignees, its successors and assigns, the entire right, title and interest in and to the Marks, the goodwill of the business in connection with which the Marks are used and symbolized by the Marks, and the right to recover for past infringements of the Marks, to have and to hold the same as fully and completely as the same might have been held by the Assignor had this assignment not been made.

Assignor agrees to take all lawful acts which Assignees may deem advisable or necessary in order to render this Assignment fully effective and to register, record and enforce the rights conveyed hereby, including without limitation, execution of lawful documents, and cooperation in production of evidence and giving of testimony in connection with proceedings to enforce the rights conveyed hereby.
