("Assignor"), and DSI GROUND SUPPORT INC., a Delaware corporation, located and doing business at 3900 West 700 South, Salt Lake City, Utah 84104, U.S.A. ("Assignee");

WHEREAS, Assignor owns and has filed applications in the United States Patent and Trademark Office for the trademarks listed in Schedule A attached hereto and made a part hereof (such trademarks and any applications and registrations therefor identified in Schedule A are hereinafter referred to as the "Marks"); and

WHEREAS, Assignee wishes to acquire Assignor's right, title and interest in and to the Marks listed in Schedule A together with the goodwill of the business in connection with which the Marks are used; and

WHEREAS, Assignor wishes to assign the Marks together with the goodwill of the business in connection with which the Marks are used;

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) in United States currency and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, grant, assign, transfer, convey and deliver to Assignee all of its right, title and interest in and to the Marks together with the goodwill of the business in connection with which the Marks are used and including the subject matter of all claims which may be obtained therefrom for Assignee's own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by the said Assignor if this assignment had not been made; together with all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for its own

use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives.

Assignor authorizes and requests the Registrar to record Assignee as the owner of the entire right, title and interest in and to the Marks, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

Assignor shall provide Assignee, its successors, assigns or other legal representatives, cooperation and assistance at Assignee's request and at Assignee's reasonable expense (including the execution and delivery of any and all affidavits, declarations, oaths, assignments, powers of attorney or other documentation as may be reasonably required) in the preparation and prosecution of any applications for registration of the Marks assigned herein or in the implementation or perfection of this assignment.

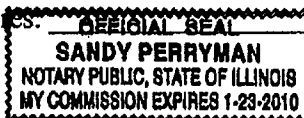

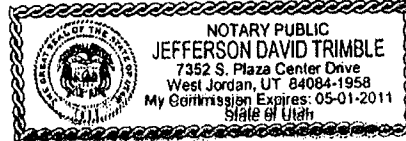
