WHEREAS, ASSIGNOR is willing to assign to ASSIGNEE all ASSIGNOR's right, title, and interest in and to the Marks;



ASSIGNOR shall promptly, upon the request of ASSIGNEE, execute such other documents and/or instruments of assignment, transfer and conveyance as ASSIGNEE may reasonably request to permit ASSIGNEE to record the assignment made by this instrument or any other documents ASSIGNEE may reasonably deem necessary or advisable to effectuate the terms and intent of this Trademark Assignment.

This Trademark Assignment is executed and delivered pursuant to the terms of that certain Agreement and Plan of Merger dated as of November 4, 2004 by and among ASSIGNOR and ASSIGNEE (the "Merger Agreement"). In the event of any conflict or inconsistency between the

provisions of this Assignment and the provisions of the Merger Agreement, the provisions of the Merger Agreement shall prevail.




