WITNESSETH:


WHEREAS, Assignee purchased from Assignor in July, 2002, certain assets including the intellectual property listed in Schedule A hereto; and

WHEREAS, the database of the U.S. Patent and Trademark Office does not show a clear title to such assets in Assignee's name, and the parties wish to correct said database.



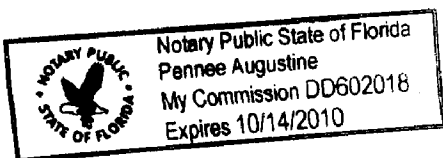
