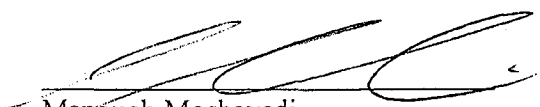

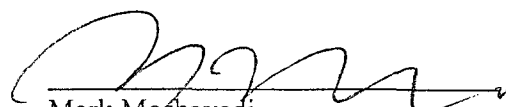
"The name of this corporation is STEC, Inc."

“The name of this corporation is SimpleTech, Inc.”

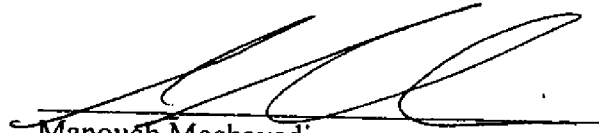
THREE: The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the Board of Directors.
