**CERTIFICATE OF MERGER
OF
QUADRIGA ART, INC.
INTO
QUADRIGA ART, LLC**

Under Section 904-A of the Business Corporation Law

August 10, 2007

It is hereby certified on behalf of the corporation named herein as the surviving corporation as follows:

FIRST: The name of the corporation to be merged is Quadriga Art, Inc., a New York corporation. The name of the surviving corporation is Quadriga Art, LLC, a Delaware limited liability corporation.

SECOND: The certificate of incorporation of Quadriga Art, Inc., the entity to be merged into the surviving corporation, was filed with the Department of State on the 4th day of December, 1956.

THIRD: The surviving corporation, a Delaware limited liability corporation, filed its certificate of formation with the Secretary of State of Delaware on July 19, 2007. The surviving corporation will file a certificate of authority with the Department of State of New York subsequent to the filing of this certificate of merger.

FOURTH: The Agreement and Plan of Merger was duly approved and executed by each constituent entity.

FIFTH: The name of the surviving limited liability corporation in the merger will be Quadriga Art, LLC which will continue its existence as said surviving limited liability corporation under such name upon the effective date of said merger.

SIXTH: The surviving corporation agrees that it may be served with process in the State of New York in any action or special proceeding for the enforcement of any liability or obligation for any domestic or foreign entity, previously amenable to suit in the State of New York, which is a constituent entity in this merger, and for the enforcement, as provided in the Business Corporation Law of the State of New York, of the right of shareholders or of such constituent domestic entity to receive payment for their interests against the surviving corporation.

SEVENTH: The surviving corporation hereby designates the Secretary of State of the State of New York as its agent upon whom process against it may be served in the manner set forth in paragraph (b) of Section 306 of the Business Corporation Law of the State of New York in any action or special proceeding. The post office address within the State of New York to which the said Secretary of State shall mail a copy of any process against the surviving corporation served upon him is:

EIGHTH: The surviving corporation agrees that, subject to the provisions of Section 623 of the Business Corporation Law of the State of New York, it will promptly pay to the shareholders of the constituent domestic corporation the amount, if any, to which they shall be entitled under the provisions of the Business Corporation Law of the State of New York relating to the right of shareholders, owners and members to receive payment for their interests.

NINTH: The merger is to become effective upon filing of this Certificate of Merger with the Secretary of State of the State of Delaware.

TENTH: The merger herein certified is permitted by the laws of the jurisdiction of incorporation of the surviving corporation and is in compliance with said laws.


