

RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT is made as of May 16, 2007, by Wells Fargo Foothill, Inc. (formerly known as Foothill Capital Corporation), as Administrative Agent ("Agent").

WITNESSETH:

WHEREAS, Agent, and Ginkgo Corporation ("Parent") and certain of its subsidiaries (together with Parent, each a "Pledgor" and together with the Parent, collectively the "Pledgors"), entered into those certain Intellectual Property Security Agreements dated as of December 12, 2003, December 18, 2003 and December 9, 2004, respectively (the "Intellectual Property Security Agreement"; the capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Intellectual Property Security Agreement), pursuant to which Pledgors granted a continuing priority security interest to Agent, in, among other things, the trademarks and patents set forth on Schedule 1 hereto; and

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 17, 2003, at Reel 014797, Frame 0407; and

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 9, 2004 at Reel 015439; Frame 0973;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 17, 2003 at Reel 2883; Frame 0907;

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on December 13, 2004 at Reel 2989; Frame 0692; and

WHEREAS, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on January 7, 2005 at Reel 3004; Frame 0849.

WHEREAS, the obligations underlying the security interest and collateral assignments are no longer owed, and Agent no longer has any further interest in the trademarks and patents and the other collateral described in the Intellectual Property Security Agreement; and

WHEREAS, Pledgors have requested that Agent release its lien on the trademarks and patents and the other collateral described in the Intellectual Property Security Agreement.
