**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (the "Release"), dated as of JULY 20, 2007, is made by Bank of America, N.A. (as successor-in-interest to Fleet Capital Corporation, "BofA") in favor of Carson Industries LLC ("Grantor"), as follows:

**WITNESSETH**

WHEREAS, Grantor has executed and delivered to BofA that Trademark Security Agreement (the "Security Agreement"), dated as of January 31, 2000 and amended as of March 23, 2006, between Grantor and BofA, pursuant to which Grantor has granted to BofA a security interest ("Security Interest") in all of Grantor's right, title and interest in and to the Trademark Collateral (as defined in the Security Agreement); and

WHEREAS, Grantor has satisfied all of its obligations as set forth in the Security Agreement; and

WHEREAS, Grantor has requested that BofA release its Security Interest in and to the Trademark Collateral granted by the Security Interest and to terminate the Security Interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, BofA hereby TERMINATES, CANCELS and RELEASES the Security Interest it has in the Trademark Collateral, including, but not limited to, each of the trademark registrations and applications set forth in Schedule A, attached hereto and incorporated herein by reference, together with the goodwill of the business symbolized by said trademark registrations and applications.


BofA hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonable necessary to effect the release of the Security Interest contemplated hereby.

For the avoidance of doubt, nothing in this Release shall be deemed a representation and warranty with respect to the Trademark Collateral, or Grantor's or BofA's right, title or interest therein or thereto.

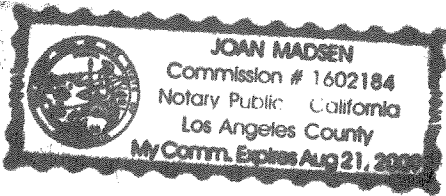
