**TERMINATION AND RELEASE OF ASSIGNMENT OF SECURITY INTEREST IN  
UNITED STATES TRADEMARKS**

This TERMINATION AND RELEASE OF ASSIGNMENT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Trademark Release") is entered into as of August 8, 2007 by and between The American Bottling Company, as successor in interest to ABC Beverage Corp. (the "Assignor") and Chase Bank of Texas, N.A., as collateral agent (the "Collateral Agent") under that certain Security Agreement between the Assignor and the Collateral Agent, dated as of October 7, 1999 (the "Security Agreement").

**WITNESSETH:**

WHEREAS, the Assignor and the Collateral Agent are parties to the Security Agreement;

WHEREAS, pursuant to the Security Agreement, the Assignor assigned and granted to the Collateral Agent a security interest in (i) all of the Assignor's right, title and interest in and to the United States trademarks, trademark registrations and trademark applications (the "Marks") set forth in Schedule A attached hereto, together with (ii) all Proceeds (as such term is defined in the Security Agreement) and products of the Marks, (iii) the goodwill of the businesses with which the Marks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same, which security interest was recorded in the Trademark Division of the United States Patent and Trademark Office on April 18, 2000 at Reel 2110 and Frame 0702; and

WHEREAS, the Assignor has satisfactorily performed and paid all the Obligations of the Assignor (as such term is defined in the Security Agreement), and the Collateral Agent now desires to confirm it has terminated and released the entirety of its security interests in the Marks and restored all right, title and interest in and to the Marks to the Assignor.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction and payment of all the Obligations secured by the Marks, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent and the Assignor hereby agree as follows:

1. The Collateral Agent hereby acknowledges that it has terminated and released in its entirety its security interests in the Marks and released, discharged, quitclaimed and relinquished unto the Assignor any and all right, title and interest in the Marks; including without limitation, all Proceeds and products of the Marks; all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; all goodwill of the businesses with which the Marks are associated; and all rights corresponding to the foregoing throughout the world.

2. The Collateral Agent hereby authorizes and requests the Commissioner of Patents and Trademarks to record this Trademark Release.

3. This Trademark Release may be executed in counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

4. This Trademark Release shall be governed by, and construed in accordance with, the laws of the State of New York.

IN WITNESS WHEREOF, each of the Collateral Agent and the Assignor has caused this Trademark Release to be duly executed and delivered by its officer thereunto duly authorized as of the date first written above.
